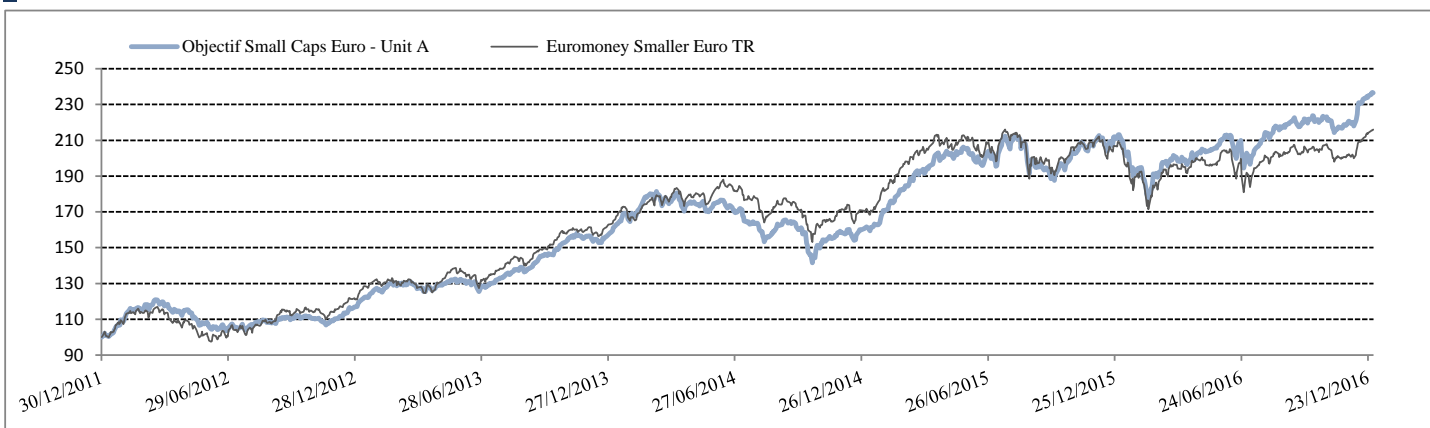
The objective of the fund is to outperform, net of fees and over the minimum recommended investment period of five years, the Eurozone small and mid cap universe as represented by the Euromoney Smaller Euro index calculated on a total return basis.

FUND MANAGERS' COMMENT - Annabelle VINATIER, Jean-François CARDINET, James OGILVY

December saw the Eurostoxx gain 7,1% to end 2016 on a positive note, up 4,2% for the year. Small caps lagged slightly with the Euromoney index adding 6,9% for the month and gaining 2,9% over the year. The SICAV, however, finished strongly, up 7,5% in December and 10,9% for the year. The largest contribution to performance in December came from GFK (+49%) which announced that KKR is to make a bid for the outstanding share capital of the company. Manutan (+16% after the full year results publication), Sopra Steria (+14%), Surteco (+14%) and Manitou (+13%) also contributed strongly. Only three stocks in the portfolio declined in December: Deceuninck (-7%), Technotrans (-5%) and Lucas Bols (-1%). Over the course of the month we initiated a new position in Biesse, an Italian manufacturer of machinery to cut wood and stone. We also added a new position in the French outsourced R&D provider Altran. Other movements included adding to our holdings in Axway and KSB and reducing the weighting in Bénéteau.

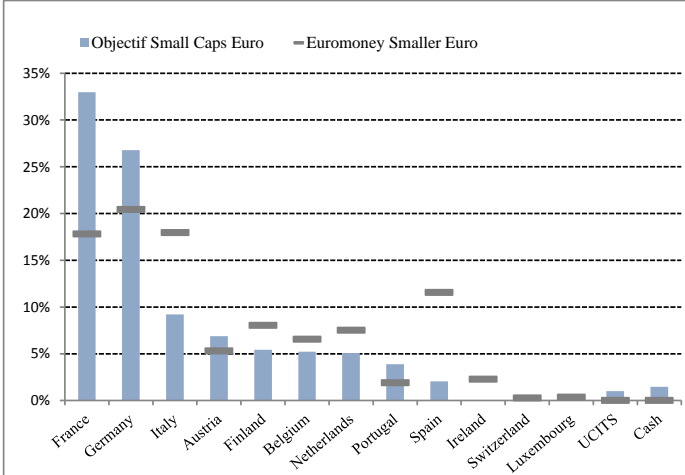

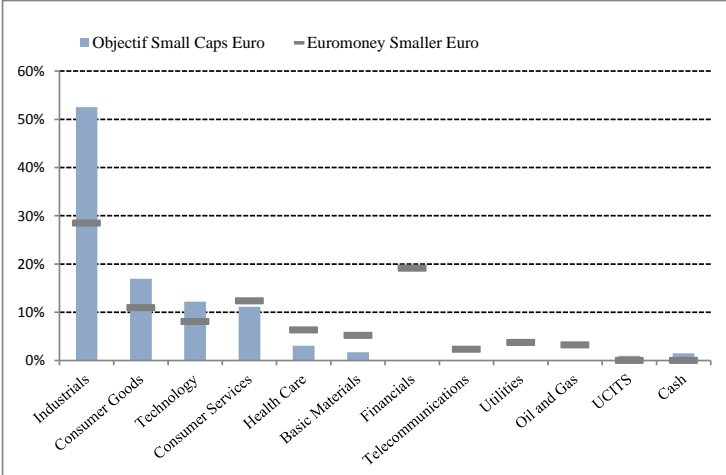
