### WHAT IS THIS PRODUCT?

**Type:** Organisme de Placement Collectif en Valeurs Mobilières (OPCVM), Société d'Investissement à Capital Variable (SICAV)

**Term:** The UCI's term is 99 years from 05/08/2003, except in the event that the Fund is dissolved before the end of the term or extended pursuant to these regulations.

#### Objectives:

The investment objective is to achieve, by applying a Socially Responsible Investment (SRI) management approach, over the recommended investment horizon of 5 years, a return (net of charges) above the following simple benchmark: MSCI EMU Small Cap. The benchmark is expressed in EUR. Nets dividends or coupons are reinvested.

To achieve this objective, the Fund will invest in small and mid-cap Eurozone companies that achieve the best economic performance over the long term, with a preference for companies that are undervalued in relation to this performance. Accordingly, the strategy applied within the SICAV is based on:

- 1) a best-in-universe approach that consists in favouring the issuers with the best extra-financial ratings, irrespective of their business sector
- 2) identifying companies with the best economic performance profile
- 3) validating this performance through financial and strategic diagnosis
- 4) selecting stocks based on the market's undervaluation of this performance at a given time
- 5) building a portfolio within the Eurozone but with no other geographical or sectoral constraints.

The UCI promotes environmental and/or social characteristics within the meaning of Article 8 of Regulation (EU) 2019/2088, the "SFDR". The SICAV is managed in accordance with the principles of the SRI label defined by the French Ministry of the Economy and Finance. The inclusion of environmental, social and governance (ESG) criteria influences the analysis of companies held in the portfolio, stock picking and weighting. ESG analysis is based on a proprietary model. Based on the various data provided by our ESG partners, the annual reports and the CSR reports of the companies and exchanges with them, an internal ESG score is established, based on both a quantitative and qualitative approach.

The methodology for covering issuers through ESG analysis is detailed in the prospectus. The analyst-managers ensure that the SICAV's ESG score is higher than the average of the top 80% in the SRI investment universe (Eurozone listed companies with a market capitalisation of between €100m and €2bn covered by the external provider). If this rule is no longer complied with, the managers would have a period of 6 months to bring the SICAV back into compliance. For the sake of integrity and objectivity, the scores used for SRI management are obtained with the support of an independent external provider. The minimum degree of exposure to the Eurozone equity markets is 75 % of the SICAV's net assets. The SICAV's portfolio is composed of shares of small companies in the Eurozone, generally corresponding to small and mid caps.

The SICAV may invest in money market instruments. The SICAV may also invest in delisted stocks (up to a maximum of 5% of the net assets). The SICAV may invest up to a maximum of 10% of its net assets in French UCIs, which may be managed by the management company.

The SICAV may use equity and equity index futures and equity and equity index options traded on regulated, organised, and/or OTC markets to hedge the portfolio and/or expose (without overexposure) it to equity risk. The SICAV may hold any warrants, certificates or rights acquired following transactions involving the portfolio securities. Within the framework of the Reliance label, two investment rules supplement the above-mentioned policy:

- 1) at least 30% of the SICAV's assets will be invested in equity instruments issued by companies whose registered office is located in France, and
- 2) at least 10% of the SICAV's assets will be invested in equity instruments issued by listed or unlisted French VSEs, SMEs or mid-caps.

The analyst-managers also undertake to exclude companies involved in coal-related activities from the SICAV's portfolio. Further information on the investment strategy can be found in the UCI's prospectus.

## WHAT ARE THE RISKS AND WHAT'S IN IT FOR ME?

**Risk indicator:**



The risk indicator assumes that you keep the product for 5 years. The actual risk may be very different if you opt to exit before the end of the recommended holding period, and you may get less in return.

The synthetic risk indicator is used to assess the risk level of this product compared with others. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity LAZARD FRERES GESTION SAS to pay you.

## WHAT HAPPENS IF LAZARD FRERES GESTION SAS IS UNABLE TO MAKE THE PAYMENTS?

The product is a co-ownership of financial instruments and deposits separate from the portfolio management company.
